The Titus Group is primarily engaged in the development, production and marketing of furniture fittings and is one of the world's leading companies in this field. It is the leading manufacturer of connectors for cabinet furniture and holds 25% of the global market share in this segment. It is also increasing its market share in the segment of concealed hinges with soft closing and other soft closing mechanisms in the furniture.

With extensive investments in the Titus Damper platform, it is developing a new business area of damping solutions, which are being incorporated into various home products, such as kitchen ovens, refrigerators and other large household appliances, drawer and sliding systems, bathroom accessories and other home furnishings. The area of growth is also the LamaCaster die casting technology and precision component castings, where extensive investments in promotion attract new customers, especially from the automotive industry.

The Group's mission is to provide solutions for precision components that improve customer's competitiveness by improving their products and efficiency and reducing the costs of their processes. It maintains the leading role and growth of the market share in the target segments by investing in product improvements and production efficiency, for which they have earmarked close to € 40 million in the last five years. The largest part of the investments was devoted to the development and launch of a new family of T-type hinges, which aim to increase market share, especially in the kitchen furniture segment.



It was created by the merger of companies: Titus from the UK, the Slovenian Lama Dekani and Tekform Australia under the umbrella of the English Titus International. Founded in 1973, Titus has grown from a privately owned fitting wholesaler to a company specializing in the development, engineering and high-volume production of precision components in the field of furniture fittings, dampers and die cast components, and an important supplier of systems for the automatic assembly of components, tooling and die casting technologies. In 2020, Titus acquired the Kinetics division from the German company Simon Group, a specialist in soft-closing systems for installation in sliding doors and pull-out systems, as well as push-opening systems.
